Following a disaster, citizens in a community may be displaced from their homes due to damage, evacuations, or other factors. The FEMA Individuals and Households Program (IHP) provides financial help and direct services to assist with housing needs that are not covered by insurance or other sources. This includes:

- Lodging expense reimbursement for short-term stays in hotels.
- Rental assistance for temporary housing
   Or direct temporary housing in the forms below:
- Multi-family lease and repair
- Recreational vehicles (RV)
- Manufactured housing unit (MHU)
- Direct lease
- Money to help repair or replace your primary home.
- Permanent housing construction.

Other Individual Assistance Programs can help support survivors with unemployment assistance, crisis counseling, and legal services. Additionally, disaster survivors can receive assistance in the form of federal disaster loans administered by the Small Business Administration.
