Did You Know? Federally recognized tribal governments can request a presidential disaster declaration.

On January 29, 2013, President Obama signed the Sandy Recovery Improvement Act of 2013, which amended the Stafford Act.

The act included a provision to provide federally recognized Indian tribal governments the option to request a presidential emergency or major disaster declaration independent of a state.

A Tribal Chief Executive or Governor may request an emergency declaration through the appropriate Regional Administrator within 30 days of the occurrence of the incident.

Further, the situation must be beyond the capability of the tribal government and that supplemental federal emergency assistance is necessary to save lives and protect property, public health and safety, or to lessen or avert the threat of a disaster.
